Mt Isa East tenements granted

- EPM 27698 and EPM 27700 granted for a period of 5 years.
- Tenements form part of Revolution Mining's Mt Isa East Project, comprising a further 3 tenement Applications and covering over 1,000 sq km in the highly prospective Mt Isa/Cloncurry Region.
- Revolution to immediately commence exploration activities.




Figure 1: Revolution's Mt Isa East Project

Revolution Mining Pty Limited ("Revolution" or "the Company") is pleased to advise that applications for two Exploration Permits for Minerals (EPM's) in the Mt Isa region of North Queensland have been successfully granted. EPM 27698 and EPM 27700 form part of the Company's Mt Isa East Project which also comprises three tenements under Application (Figure 1 & Table 1). Grant of the remaining three tenements is anticipated in the coming months.

In December 2020 Revolution identified a prospective trend of copper gold targets associated with untested historical workings and moved quickly to secure a large tenure holding in the region covering over 1000 sq kilometres.

Commenting on the tenement grants, Revolution Director Nic Capozzi, said:

"The base metal region of Mt Isa and Cloncurry are synonymous with world-class copper and zinc deposits and the mineral field is a sought-after jurisdiction for base-metal style exploration which is well supported by existing infrastructure.

The Revolution Team are delighted to have secured a large tenement package (~1,200 square kilometers) east of Mount Isa which is prospective for IOCG and shear hosted copper (and gold) mineralization."

Revolution's primary objective at Mt Isa East is to discover and plan development pathways for Cu-Au resources. Despite the area being previously explored by surface geochemistry, there is an obvious lack of drilling in zones of known copper mineralization. A number of prospects can be considered more advanced and close to drill ready, whilst a larger number of conceptual targets exist within a large tenement area. Revolution propose to conduct significant greenfields exploration over the entire tenure to locate and rank new prospects.

Revolution will now initiate the exploration program Mt Isa East making use of the 2021 field season. Initial exploration activity is expected to consist of data integration and review, refinement of metallogenic models and acquisition of reconnaissance geochemical data.
