Holbrook and Bombala tenements granted in Lachlan Fold Belt, NSW

- **Bombala (EL9160) and Holbrook (EL9162) granted for a period of 6 years.**
- **Tenements covering 381 sq km in the highly prospective Lachlan Fold Belt (LFB).**
- **Revolution to immediately commence exploration activities.**

Revolution Mining Pty Limited (“Revolution” or “the Company”) is pleased to advise that applications for Exploration Licences (EL’s) in the highly prospective Lachlan Fold Belt, NSW have been successfully granted. EL9160 (Bombala) and EL6192 (Holbrook) have both been granted for a term of 6 years.

At Bombala, Revolution has secured tenure (126 square kilometers) located north of Bombala township. The project hosts Volcanic Hosted Massive Sulphide mineralisation in a geological setting akin to the Woodlawn and Captains Flat volcanogenic massive sulphide deposits in the eastern LFB. Exploration to date has identified multiple prospects and significant mineralization intersected in historical drilling.

At Holbrook, Revolution has secured a large tenement (250 square kilometers) covering the Holbrook molybdenum district, located east of Holbrook township. The project is prospective for large-scale intrusive-related molybdenite - copper (and gold) mineralization, with multiple prospects and small-scale historical production.

Commenting on the tenement grants, Revolution Director Nic Capozzi, said:

“The granting of EL9160 and EL9162 and is a positive step in the Company’s strategy to increase our exploration footprint in the highly prospective Lachlan Fold Belt region. Both projects already show encouraging signs with mineralisation on ground associated with historic workings. We believe the geology has all the right attributes to host a potential discovery of IRGS and/or porphyry at Holbrook and VMS and or shear hosted gold mineralisation at Bombala. Revolution will now be able to actively explore a number of high-priority prospects in both project areas as it looks to add value to both assets.”

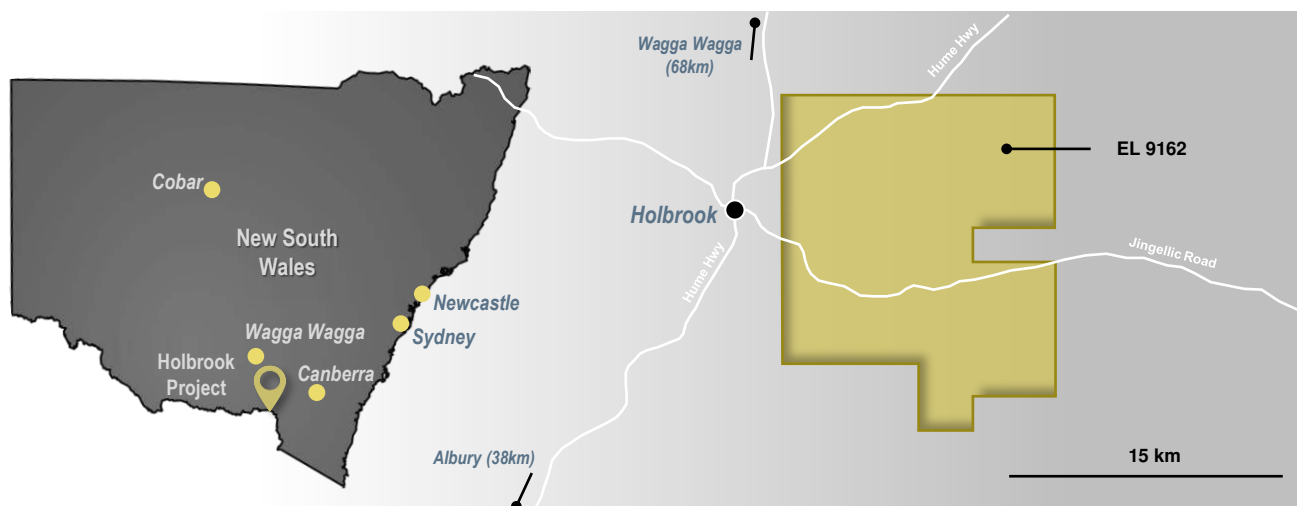


Figure 1: Revolution's Holbrook Project

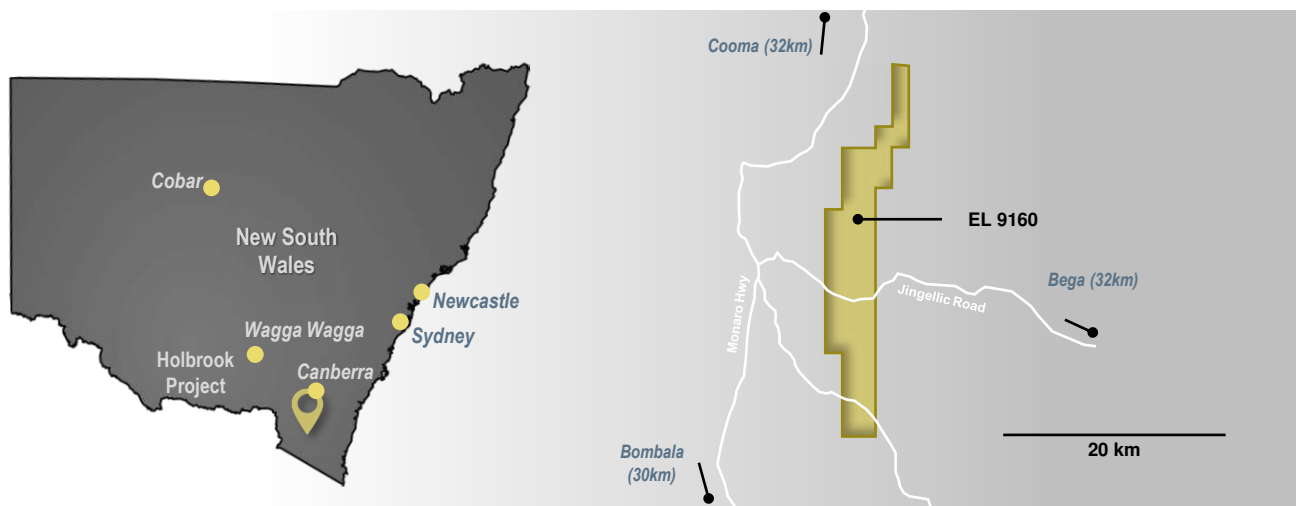


Figure 2: Revolution's Bombala Project
